AMENDMENT TO THE WOW APP TERMS AND CONDITIONS ENTERED INTO BETWEEN DIALOG AXIATA PLC AND THE MERCHANT

The Parties:

Dialog Axiata PLC, bearing company number PQ 38 and having its registered office at 475, Union Place, Colombo 02 ("Dialog"),

The Merchant shall mean a person or corporate that has entered into an agreement with Dialog in the form of terms and conditions ("Agreement") to make available for sale through the Wow Mall contained in the Wow App, goods including the vouchers of the Merchant ("the Merchant").

Background:

- A. The Parties entered into the Agreement for the Merchant to make available for sale through the Wow Mall contained in the Wow App, goods including the vouchers of the Merchant.
- B. The Parties have agreed to amend the Agreement and record the amendments as outlined herein below.

It is agreed by the Parties:

1. Interpretation

The following rules apply unless the context requires otherwise:

- a) Except as expressly amended and supplemented hereby, the Agreement shall remain unaltered and in full force and effect.
- b) In the event of any conflict between the terms of this Amendment and the terms of the Agreement, the terms of this Amendment shall prevail but only to the extent of such conflict.
- 2. The Parties agree to amend the Agreement by:
 - a) The addition of the following as a new sub-clause 4.14 under clause 4 Conditions of Utilization of the App.

"4.14 In relation to Deal Zone: The Merchant of Deal Zone shall be permitted to offer deals on the Wow Mall as coupons. These offers should be made redeemable either online or offline by the Customers. The percentage of offer, redemption method and validity of the offer has to be decided by the Merchant. The offer redemption shall be between the Merchant and the Customer.

Pursuant to the creation of the user logins and the same being passed to the Merchant, the Merchant shall login and create the offer via the backend. The coupon artworks shall be designed and provided by the Merchant."

- 3. The Agreement is amended with effect from 12th May 2023.
